# **Traditional Skateboards**

#### Definition:

- A flat object with wheels attached that can be moved by pushing, pulling, gravity, or body movement.
- Most regulations governing skateboards apply to roller blades, in-line skates, roller skates and coasters as well.



## State Regulations:

- Helmets required if under 18 years of age (21212 CVC)
- No age limit or license required

## City Regulations:

- Must obey all applicable bicycle laws (13.54.010 BMC)
- Must obey all traffic signs and signals (13.54.040 BMC)
- Shall not operate on the street or sidewalk in a business district (13.54.020 BMC)
- Shall not operate in any public park or city parking lot (13.54.020 BMC)
- Shall not operate on the sidewalk in a residential district when pedestrians are present (13.54.020 BMC)
- Shall not ride at night on any street, alley or sidewalk (13.54.050 BMC)
- No passengers allowed (13.54.020 BMC)

# **Electrically Motorized Skateboards**

- Any wheeled device that has a floorboard designed to be stood upon when riding (313.5 CVC)
- Designed to transport only one person (313.5 CVC)

- Can be powered solely by a propulsion system or by human propulsion (313.5 CVC)
- Less than 1000 watts (313.5 CVC)
- Maximum speed of 20 mph (313.5 CVC)





- Helmets required if under 18 years of age (21292 CVC)
- 15 mph speed limit (21294 CVC)
- Required lighting at night (21293 CVC)
- Must be 16 years of age to operate (21292 CVC)

## City Regulations:

- Must obey all applicable bicycle laws (13.54.010 BMC)
- Must obey all traffic signs and signals (13.54.040 BMC)
- Shall not operate on the street or sidewalk in a business district (13.54.020 BMC)
- Shall not operate in any public park or city parking lot (13.54.020 BMC)
- Shall not operate on the sidewalk in a residential district when pedestrians are present (13.54.020 BMC)
- Shall not ride at night on any street, alley or sidewalk (13.54.050 BMC)
- No passengers allowed (13.54.020 BMC)

# **Motorized Skateboards**

- Any wheeled device that has a floorboard designed to be stood upon when riding (313.5 CVC)
- Designed to transport only one person (313.5 CVC)
- Can be powered solely by a propulsion system or by human propulsion (313.5 CVC)
- Over 1000 watts (313.5 CVC)

• Maximum speed over 20 mph (313.5 CVC)



## State Regulations:

• A motorized skateboard shall not be propelled on any sidewalk, roadway, or any other part of a highway or on any bikeway, bicycle path or trail, equestrian trail, or hiking or recreational trail (i.e. they are not street legal). (21968 CVC)

## City Regulations:

• N/A as they are not street legal

# **Traditional Bicycles**

#### Definition:

• A device propelled by human power through a belt, chain or gears, and has one or more wheels. (231 CVC)



## State Regulations:

- Helmets required if under 18 years of age (21212 CVC)
- Must obey all applicable traffic laws (21200 CVC)
- No passengers allowed unless specifically designed to do so (21204 CVC)
- Required equipment such as brakes, lighting at night, etc. (21201 CVC)
- No age limit or license required

#### City Regulations:

- Must obey all traffic signs and signals (13.52.130 BMC)
- Required lighting at night (13.52.140 BMC)
- Shall not operate on the sidewalk in a business district (13.52.100 BMC)
- Shall not operate on the sidewalk in a residential district when pedestrians are present (13.52.100 BMC)
- Must yield to pedestrians in public parks and playgrounds and obey all posted park rules and speed limits (13.52.180 BMC)
- No passengers allowed (13.52.110 BMC)

# E-Bikes (Class 1)

- Electric bicycle that provides pedal-assist only (i.e. the motor only assists when the rider is pedaling). (312.5 CVC)
- It does not have a throttle. (312.5 CVC)
- Motor assist cuts off when the bike reaches 20 mph. (312.5 CVC)
- <u>These are the types of e-bikes we provide to our residents and visitors via our Spin contract</u>

- Helmets required at any age (21212 CVC)
- Must obey all applicable traffic laws (21200 CVC)
- No passengers allowed unless specifically designed to do so (21204 CVC)
- Required equipment such as brakes, lighting at night, etc. (21201 CVC)
- Must be 16 years of age to operate. No license required. (22213 CVC)

### City Regulations:

- Must obey all traffic signs and signals (13.52.130 BMC)
- Required lighting at night (13.52.140 BMC)
- Shall not operate on the sidewalk in a business district (13.52.100 BMC)
- Shall not operate on the sidewalk in a residential district when pedestrians are present 13.52.100 BMC)

## **E-Dirt Bikes**

- Resembles an e-bike but with no pedals or ability to be pedaled.
- Powered by an electric motor and throttle only.
- Designed for off road use only
- Can reach speeds of 40-50 mph.



• A shall not be propelled on any sidewalk, roadway, or any other part of a highway or on any bikeway, bicycle path or trail, equestrian trail, or hiking or recreational trail (i.e. they are not street legal).

## **Motorized Scooters**

#### Definition:

- Two-wheeled device that has handle bars.
- Designed to be stood upon when riding (or can have a seat with footrests).
- Powered by an electric motor.



## State Regulations:

- Helmets required if under 18 years of age (21235 CVC)
- Shall not operate on the sidewalk (21235 CVC)
- Must obey all applicable traffic laws (21221 CVC)
- 15 mph speed limit (22411 CVC)
- No passengers allowed (21235 CVC)
- Required equipment such as brakes, lighting at night, etc. (21235 and 21223 CVC)

Must be 16 years of age and have valid driver's license or permit to operate (21235 CVC)

## **E-Go Karts**

#### Definition:

- Small, battery-powered vehicle that uses an electric motor.
- Can be controlled by a joystick or pedal.
- Can reach speeds of 25-50 mph

• An e-go kart shall not be propelled on any sidewalk, roadway, or any other part of a highway or on any bikeway, bicycle path or trail, equestrian trail, or hiking or recreational trail (i.e. they are not street legal).
