Subject: Discussion of Potential Increase in City Council Compensation

### **RECOMMENDATION**

Staff recommends that the Council discuss City Council compensation and whether to direct staff to prepare an ordinance increasing Council pay.

#### **BACKGROUND**

At the May 20, 2024, Council meeting, Vice Mayor Beach requested that the City Council agendize a discussion of increasing the Council's compensation, and the Council concurred. The City Council last discussed the issue of Council compensation on October 5, 2015, and tabled the matter at that time. Pursuant to Burlingame Municipal Code section 2.04.030(a), Burlingame Council pay is currently set at \$590 per month, an amount that hasn't changed since 1999. In addition to salaries of \$590 per month, Burlingame City Councilmembers are eligible to receive the benefits listed in the attached document.

#### **DISCUSSION**

The method for establishing City Council pay is set forth in California Government Code Section 36516. On June 29, 2023, Governor Newsom signed Senate Bill 329 (SB 329). The bill allows cities a one-time opportunity to "reset" City Council salaries to take into account inflation, the work done by local government officials, and the need to ensure that people are not discouraged from seeking city office due to the low pay and high demands of that office. The salary increase, or "reset," is based on a city's population size.

Under Government Code §36516(a)(2)(A), the City Council may, by ordinance, increase City Councilmember salaries to an amount up to \$950 per month, which is the rate set for cities with populations up to and including 35,000. (The salary for cities with a population between 35,001 and 50,000 is \$1,275 per month.) Pursuant to Government Code §36516.5, salary increases may take effect only when at least one member of the Council commences a new term. Should the City Council determine that it wishes to increase Councilmember pay beyond \$590 per month, then any salary increase would be effective after the November 2024 election.

SB 329 also allows future salary increases for Councilmembers beyond the amount provided in Government Code §36516(a) by an ordinance or by an amendment to an ordinance, as long as

the amount of the increase does not exceed the greater of either of the following: 1. an amount equal to 5% for each calendar year from the operative date of the last adjustment of the salary in effect when the ordinance or amendment is enacted; or 2. an amount equal to inflation since January 1, based upon the California Consumer Price Index (CPI), which shall not exceed 10% for each calendar year.
