AWARDING A \$289,133 CONSTRUCTION CONTRACT FOR THE DONNELLY
PARKING GARAGE ELEVATOR MODERNIZATION PROJECT TO TK ELEVATOR
CORPORATION, AUTHORIZING THE CITY MANAGER TO EXECUTE THE
CONSTRUCTION CONTRACT, AND APPROVING A FUND TRANSFER OF \$165,000
FROM THE PARKING ENTERPRISE FUND

- **WHEREAS**, the City of Burlingame is a member of the Sourcewell JPA and has utilized Sourcewell's cooperatively purchased contracts in the past; and
- **WHEREAS**, TK Elevator Corporation holds a multi-year Sourcewell contract (Contract No. 080420-TKE) to provide elevator services to Sourcewell participating entities; and
- **WHEREAS**, choosing a contractor with a current Sourcewell contract complies with the City of Burlingame's procurement policies for procuring work on new construction as an alternative to competitive bidding; and
- **WHEREAS**, on June 16, 2020, Sourcewell issued a notice inviting bid proposals for Elevators, Escalators and Moving Sidewalks with Related Equipment, Services and Supplies to result in a contracting solution for Sourcewell participating entities, and
- **WHEREAS**, on August 4, 2020, all proposals were received and opened via Sourcewell's procurement process; and
- **WHEREAS**, TK Elevator Corporation was selected by Sourcewell for Contract No. 080420-TKE; and
- **WHEREAS**, City staff worked with TK Elevator Corporation to develop the scope of work and not-to-exceed amount of \$289,133 for the project; and
- **WHEREAS**, a fund transfer in the amount of \$165,000 from the Parking Enterprise Fund is requested to fully fund the construction of the project.
- **NOW, THEREFORE, be it RESOLVED**, and it is hereby ORDERED, that the Contract Documents attached hereto and incorporated herein are approved and adopted; and
- **BE IT FURTHER RESOLVED** that the scope of work from TK Elevator Corporation for said project in the amount of \$289,133, and the same hereby is accepted; and

BE IT FURTHER RESOLVED that the \$165,000 fund transfer from the Parking Enterprise Fund is approved; and

BE IT FURTHER RESOLVED that a contract be entered into between the successful bidder hereinabove referred to and the City of Burlingame for the performance of said work, and that the City Manager is authorized on behalf of the City of Burlingame to execute said contract and to approve the faithful performance bond and the labor materials bond required to be furnished by the contractor.
