RE: Private Tree Removal Application - 1236 Capuchino Ave

The application for the removal of the (3) Acacia groups has been reviewed. These trees are poorly located on a property line. They are damaging a fence and are touching neighboring roof lines despite pruning efforts. Evidence of topping exists. Many are multi-stem and show evidence of decay.

Therefore, I am approving removal of these trees based on the criteria in Chapter 11.06 of the Municipal Code, Urban Reforestation and Tree Protection Ordinance, section 11.06.060 which allows removal for the following reasons: (d) (1) the condition of the tree with respect to the proximity to existing or proposed structures, yards, driveway and other trees... and, (d)(7) the economic consequences and obligations of requiring a tree to remain.

Replacement with ONE 24-inch box standard size single stem landscape trees (no fruit, nut, Japanese Maple, or cypress) will be required to be planted anywhere on the private property as defined in Section 11.06.090. Replacement trees must have a mature height of over 15 feet.

Adjacent property owner(s) within 100 feet of the property listed above are also receiving notification of this decision. Appeals to this decision or any of its conditions or findings, must be filed in writing to our office by, *April 14, 2023* as provided in Section 11.06.080 of the *Urban Reforestation and Tree Protection Ordinance* (Burlingame Municipal Code Chapter 11.06). The permit will be issued at the end of the workday on *April 14, 2023*, if no appeal has been received by that date.

NOT OUR TREE...

TREES IN PRIVATE EASEMENT & ALLEYWAYS

Easements are defined as a recorded right or interest in the land that belongs to someone else and which entitles the holder to some use, privilege, or benefit out of or over said land (25.108.060).

Have you ever wondered who takes care of the trees in the easement areas in the City?

City policy identifies trees in City easements as private trees. Although City staff and public utility companies may access such easements to service existing utilities and for safety reasons, the trees in alleyways and easements between properties were not planted by the City and are not maintained or removed by the City. Property owners on either side of the alleyway or easement are generally responsible for the maintenance and/or removal of easement trees.

What if the private tree in the easement is of protected size?

Any easement or alleyway tree situated on privately owned property (as determined by the property deed) that has a trunk circumference of 48" or more, when measured 54" above the natural grade, is a "protected" tree. That means it needs a Protected Tree Removal Permit to remove and is subject to the provisions in Chapter 11.06 of the Burlingame Municipal Code, Urban Reforestation and Tree Protection Ordinance. You can find the permit on the City website at https://burweblink.burlingame.org/Forms/treepermit. If the tree is not of protected size, the property owner can remove the tree without a permit.

Did you know?

Public Works hires a contractor once a year to clean out the easements and remove debris, typically in May or June per the Municipal Code 11.08.010 Weed and Rubbish Deemed a Nuisance. The contractor removes trash and cuts the weeds and grass to clear the utilities and have a safe access path.
