# 5. PUBLIC COMMENTS - NON-AGENDA

Rick, a lifelong resident of Burlingame said his heart aches for the recent tragedy and stated he wants to bring awareness to a bigger issue—e-bikes. He stated the way kids treat e-bikes and the lack of training is a sore issue that needs to be addressed. He stated this is not an isolated incident involving an e-bike and he urged staff to come together to alleviate the problem.

Sandy, another long resident of Burlingame, inquired about training classes and or permitting for e-bikes.

Leslie Beatty acknowledged what happened in Burlingame last week and stated it is an opportunity for the City to lead. She shared her observations of comments online regarding the incident and said the collision factor is complicated. She encouraged the City to move past blame and into what can be done. Ms. Beatty stated this is the third pedestrian fatality in Burlingame this year. She encouraged the City to continue making improvements to make streets safer.

Manito Velasco pointed out the positive changes the City has implemented recently such as red zones near crosswalks, RRFBs, new crosswalks, lowering of speed limits, and pedestrian head starts. With regard to the recent tragedy, he said it behooves the City to share exactly what happened when the investigation is complete. He stated kids are currently getting blamed for the "chain reaction" incident.

Gavin Duncan, who resides in the area, asked various questions regarding the data used in the traffic analysis.

Manito Velasco stated the model doesn't reflect what happens on a daily basis. He stated that without the train preemption in the simulation, it's not a true representation of existing conditions. Mr. Velasco pointed out unintended consequences and asked staff to consider implementing the pedestrian countdown signals now.

# **ACTION**

Commissioner Johnson made the follow motion, seconded by Commissioner Israelit:

Move that, we accept the staff recommendations with the addendum of looking into adding the pedestrian countdown signals as soon as possible.

The motion passed by a roll call vote of 4-0.

Vision Zero Update – The Vision Zero Project has completed its first phase consisting of data collection and public outreach. In a 3+ month period, over 250 participants contributed more than 650 responses to the interactive Online Map Survey with an additional 200 participants during pop-up events at the Farmer's Market and Burlingame High School. The project team also held 7 meetings with the Citizen's Advisory Committee, Project Task Force, TSPC, and City Council. A progress report is scheduled to be presented to the City Council on September 2nd as the project enters into the second phase consisting of Draft Plan and Priority Location Development.

**Accelerated Mobility Plan (AMP)** – CityThreads to make a presentation related to the next phases to City Council. This will include potential options and costs related to those phases. City staff to provide an update regarding efforts of other agencies who have previously participated in an AMP.

# RECOMMENDATION

Staff recommends that the Commission receive an update on various Public Works – Engineering projects and activities.

# **BACKGROUND**

- Peninsula Avenue/Humboldt Avenue The cities of San Mateo and Burlingame have been working to provide improvements to this intersection. High visibility crosswalks, lead pedestrian intervals (LPI), and pedestrian related signage have already been added to the intersection. San Mateo is current seeking a traffic design firm to review potential traffic signal and/or lane reconfiguration changes for implementation.
- Occidental Pedestrian Improvements Construction is underway for this City and grant funded project. Project includes new high visibility crosswalks, pedestrian ramps, traffic islands, stop signs, and some minor landscaping. Pilot stops signs are up at Occidental/Chapin.
- Hillside Drive Pedestrian Improvements Update Work order to install larger stop signs along Hillside Drive at both Alvarado Drive and Hillside Circle has been submitted. In addition to the larger signs, reflective red strips will be installed on the poles. Layout for the pedestrian improvements along Hillside at Carlos Avenue has been completed. Staff use this layout to solicitate quotes for the work.

# DISCUSSION

Items on this list are matters that would typically be addressed by City staff on an administrative level or are City Capital Improvement Projects.
