RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURLINGAME SETTING A PARKLET USE FEE STRUCTURE AND AMENDING THE MASTER FEE SCHEDULE ACCORDINGLY

WHEREAS, in 2020, the City Council initiated a series of measures to facilitate safe outdoor dining in the midst of the COVID-19 pandemic; and

WHEREAS, the measures included implementing temporary weekend street closure programs for both Downtown Burlingame Avenue and Broadway and installing parklets on side streets in the Downtown Burlingame Avenue area; and

WHEREAS, the street closure program was discontinued in favor of allowing full-time parklets; and

WHEREAS, at the August 16, 2021, City Council meeting, the Council approved the extension of the parklet program through Labor Day (September 5) 2022; and

WHEREAS, at the December 6, 2021, City Council meeting, recognizing the popularity of the parklet program and the need to provide additional certainty to businesses, the Council approved extending the parklet program through December 31, 2022, with the provision that rent be charged for the use of publicly owned space; and

WHEREAS, at the January 3, 2022, meeting, the City Council adopted a resolution to adopt a \$1,500 flat rate for use of parklet area; and

WHEREAS, at the January 18, 2022, meeting, the City Council passed a resolution to adopt a \$250 per month cleaning fee per parklet; and

WHEREAS, at the September 19, 2022, City Council meeting, the Council approved extending the parklet program through June 30, 2024, with a recommendation to review the fee structure; and

WHEREAS, at the December 4, 2023, City Council meeting, the Council indicated support for establishing a semi-permanent parklet program, beyond the temporary program's expiration on June 30, 2024; and

WHEREAS, at the June 3, 2024, City Council meeting, the Council reviewed and discussed the recommendations of the Economic Development Subcommittee regarding the parklet fee structure, the basis for the fee calculation, and term of agreement for parklets in the Downtown Burlingame Area and Broadway Area and provided direction to staff; and

WHEREAS, the City Council held a duly noticed public hearing to consider the parklet use fee structure for parklets in the Downtown Burlingame Avenue Area and Broadway Area; and

<u>Section 1</u>. The foregoing recitals are true and correct and incorporated into this Resolution by this reference, as well as the minutes, staff reports, and legislative record.

<u>Section 2</u>. The fee structure ("fee") listed in Exhibit "A" to this Resolution, attached hereto and incorporated herein by reference, shall be imposed at the rates set forth in Exhibit "A"; and the Master Fee Schedule shall be amended to incorporate said fees.

Section 3. This Resolution shall take effect upon adoption.

Parklet Use Fee Structure

Application Fee: \$1,801 (one-time fee)

Space Use Fee: \$15/sf per year (Downtown Burlingame Area)*

\$6/sf per year (Broadway Area)*

* calculation will include area covered by water walls

Cleaning Fee: \$3,180 per year

Inspection Fee: \$1,800 per year
