**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURLINGAME  
AUTHORIZING THE CITY MANAGER TO PROCURE SOFSURFACES DURASAFE  
PLAYGROUND TILES AND INSTALLATION; AND AUTHORIZING THE CITY  
MANAGER TO EXECUTE AN AGREEMENT WITH SUAREZ AND MUÑOZ  
CONSTRUCTION, INC. FOR THE RAY PARK PLAYGROUND RENOVATION PROJECT,  
CITY PROJECT NO. 84440**

**WHEREAS**, the City of Burlingame Capital Improvement Program has identified the Ray Park Playground as needing replacement due to its age and condition; and

**WHEREAS**, the City of Burlingame has taken appropriate proceedings to authorize construction of the public work and improvements provided for in the attached Contract; and

**WHEREAS**, a notice was duly published on January 2, 2019 for bids for the contract for the Ray Park Playground Renovation Project; and

**WHEREAS**, on January 23, 2019, the City received five proposals, which were opened before the City Clerk and representatives of the Parks & Recreation Department; and

**WHEREAS**, Suarez & Muñoz Construction, Inc. submitted the lowest responsive and responsible bid for the project in the amount of \$299,700.00; and

**WHEREAS**, the SofSurfaces Durasafe playground tiles and installation services can be purchased thorough Sourcewell, a government purchasing contract for \$129,499.38.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURLINGAME  
RESOLVES AND ORDERS AS FOLLOWS:**

1. The facts in the recitals above and in the staff report are true and correct.
2. The Plans and Specifications, including all addenda, are approved and adopted.
3. The bid from Suarez & Muñoz Construction, Inc. in the amount of \$299,700.00 is the lowest responsive and responsible bid for said project and is accepted.
4. The City shall enter into a contact with the successful bidder, Suarez & Muñoz Construction, Inc. for the performance of the Ray Park Playground Renovation, Project No. 84440, and the City Manager is authorized on behalf of the City of Burlingame to execute said contract and to approve the faithful performance bond and the labor materials bond required to be furnished by the contractor.

5. The City Manager is authorized on behalf of the City of Burlingame to procure SofSurfaces, Inc. Durasafe playground tiles and installation services at a cost of \$129,499.38 through Sourcewell.
