Housing Update

Goal is to meld the intersection of climate and housing production and making sure the message on both are coordinated and not using one to prevent the other. RHNA 16,500 county-wide allocation and thinking it will at least double or even more

- 8,473 total units built or under construction
- County has invested \$110 and another \$50 million next year - so total \$150 and helped 2,055 units to be constructed (does not include all the BMR units and city owned land without county funding).
- State - \$2 billion in funding for housing, \$1 billion to fund programs that facilitate affordable, \$650 million in new funding for local governments to address homeless, \$250 million for planning work

Climate Change Update

- Climate impacts in SMC
- Warmer, flooding and sea levels increase 1-2 feet by 2050, weather extremes, bigger events like fires and floods
- Plan and Prepare - Climate viewer, online adaptation library, adaption toolkit, technical assistance, community resilience grants

Opportunities to engage communities, educate, drive policy and meld the reality to the policy. Concerns over existing housing and building stock and not wanting to leave that behind. Spatial challenges to implement these codes. Resource mitigation toolbox and figuring out how to organize data and information.
