Subject: Ordinance Amending Chapter 15.06 and Adopting a New Chapter 15.07 of the

Burlingame Municipal Code to Prohibit Wasteful Water Use Practices (CEQA Determination: Exempt Pursuant to State CEQA Guidelines Sections 15378

and 15061(b)(3))

## **RECOMMENDATION**

Staff recommends that the City Council conduct a public hearing to introduce the attached ordinance to amend Municipal Code Chapter 15.06 and to adopt a new Chapter 15.07 to prohibit wasteful water use practices. In order to do so, the City Council should:

- 1. Receive the staff report and ask any questions of staff.
- 2. Request that the City Clerk read the title of the proposed ordinance.
- 3. By motion, waive further reading and introduce the ordinance.
- 4. Conduct a public hearing on the proposed ordinance.
- Following the public hearing, discuss the ordinance, adopt the first reading of the ordinance, and direct the City Clerk to bring the ordinance back for adoption at the next regular City Council meeting.

### **BACKGROUND**

Staff is in the process of updating the City's Urban Water Management Plan in accordance with the requirements of the California Water Code, and will bring the Plan to the City Council for adoption at a future meeting. California Water Code Section 10632(a)(7) requires an urban water supplier to adopt a water shortage contingency plan as part of its urban water management plan that consists of a description of the legal authorities that empower the urban water supplier to implement and enforce its shortage response actions specified in paragraph (4) that may include, but are not limited to, statutory authorities, ordinances, resolutions, and contract provisions. The shortage response actions listed in the aforementioned paragraph (4) include locally appropriate supply augmentation actions, demand reduction actions, operational changes, and mandatory prohibitions against specific water use practices. Moreover, California Water Code Section 10631(e) states that a water supplier must provide a description of its water demand management measures, which includes water waste prevention ordinances, metering, and conservation

pricing. Staff has developed the attached ordinance to comply with the California Water Code by establishing the legal authority to implement the City's Water Shortage Contingency Plan and create a new water waste prevention ordinance.

## **DISCUSSION**

Municipal Code 15.06 grants the City Council the ability to adopt water use regulations outlined in Chapter 15.06.040; however, it does not mention the City's Water Shortage Contingency Plan. Staff proposes to reference the Water Shortage Contingency Plan to ensure that the City has the legal authority to execute water use practices as described in this plan.

Additionally California Water Code section 10631(e)(1)(B)(i) requires a water supplier to provide a description of its water waste prevention ordinance. Since the City of Burlingame does not have a permanent water waste prevention ordinance, staff recommends that the City Council adopt one that targets wasteful water use practices and conserves the City's water supply. Unlike Municipal Code 15.06, which is in effect during water shortage emergencies, this water waste prevention ordinance will be in place at all times. The proposed water waste restrictions are based on Governor Brown's Executive Order B-40-17, which was issued during the previous drought. Moreover, staff has reviewed water waste restrictions from neighboring jurisdictions and compared them in the below table for informational purposes.

During the previous drought, City staff developed a public outreach program to educate residents about restricted water waste practices. This program included the dissemination of mailers, postcards, and yard signs. Staff has continued to maintain the water conservation hotline (650-558-7612) and water conservation email (waterconservation@burlingame.org), where members of the public may contact staff with questions about water conservation or to report water waste. When new water waste restrictions are in effect, staff will conduct public outreach to the community and its water customers to ensure compliance with these water waste restrictions, and will issue citations and fines as a last resort.

# FISCAL IMPACT

Adoption of the ordinance amending Chapter 15.06 is not anticipated to incur fiscal impact since the intent is to ensure that the City can execute and enforce the Water Shortage Contingency Plan. Adoption of the ordinance adding the new Chapter 15.07 to prohibit wasteful water use practices is anticipated to have an impact on staffing resources to enforce and respond to complaints, and will highly depend on compliance level by the community.
