

RESOLUTION NO. 067-2026

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BURLINGAME APPROVING AN AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING WITH THE COUNTY OF SAN MATEO FOR PARTICIPATION IN THE MULTI-JURISDICTIONAL SAFETY ELEMENT PROJECT TO EXTEND THE TERM TO DECEMBER 31, 2026

WHEREAS, changes to State law require local jurisdictions to review and update the Safety Elements of their General Plans to address climate adaptation and resiliency strategies, fire hazards, flood hazards, and evacuation routes; and

WHEREAS, in 2023, nine jurisdictions in the County of San Mateo (“County”) formed a Safety Element Collaborative to address the legal requirements to update Safety Elements and to share analysis and resources for greater efficiency for the jurisdictions participating in this collaborative effort; and

WHEREAS, in 2023, the City of Burlingame (“City”) joined the Peninsula Resilience Planning project, a collaborative multi-jurisdictional effort of nine jurisdictions in the County supported by a consulting team led by PlaceWorks to address the legal requirements to update Safety Elements and to share analysis and resources for greater efficiency for the jurisdictions participating in this collaborative effort; and

WHEREAS, on June 15, 2023, the County and City (collectively, the “Parties”) entered into a Memorandum of Understanding (“MOU”) for participation in the Safety Element Multi-Jurisdictional Project (Resolution No. 016-2023); and

WHEREAS, the term of the MOU is set to expire on June 15, 2026; and

WHEREAS, the Parties now desire to formally extend the MOU and acknowledge that all terms, conditions, and requirements of the MOU remain in effect through the new amended expiration date of December 31, 2026, in order to accommodate the duration of time needed to complete the CAL FIRE regulatory process and complete City Council adoption of the Safety Element Update.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURLINGAME DOES HEREBY:

1. Approve an Amendment to the Memorandum of Understanding between the County of San Mateo and City of Burlingame for the Multi-Jurisdictional Safety Element Project to extend the term to December 31, 2026; and
2. Authorize the City Manager to execute said Amendment.
